GAME RULES FOR ONLINE BETTING

PRIOR SPECIFICATIONS

The organizer of the fixed-odds distance betting games of chance is **MOZZARTBET MALTA LIMITED**, a Maltese company registered with the Malta Companies Register under no. C83980, with registered office in Office 2D, Soho St. Julians, Punchbowl Centre, St. Elia Zammit, St. Julians, STJ3154, Malta (hereinafter: "Bookmaker").

The regulation for the operation of remote fixed-odds bets enters into force from the date of approval by the National Gaming Office and will govern all bets accepted by the Bookmaker on its own gaming platform, respectively on the website www.mozzartbet.ro (hereinafter referred to as "the website").

The Game Rules are brought to public knowledge by posting on the own website.

Customers must read and understand the provisions below. Participating in games of chance such as remote fixed-odds bets, organized by the Bookmaker, implies the unconditional acceptance by the customer of the Game Regulations, the Terms and Conditions and any other rules, established by the Bookmaker and brought to the attention of the Participants.

A. General rules for making the bet

- (1) These Regulations are supplemented by the Terms and Conditions, the legal provisions and the instructions of the Organizer and represent the basis for concluding a contract regarding participation in the game ("Contract").
- (2) **betting** (online) is the game of chance that takes place by means of remote communication means, in which the Customer indicates the results of the events proposed by the Bookmaker (hereinafter referred to as "Events"), to which it grants according to its own criteria a certain numerical value (called QOTA), the Customer deciding independently the number and type of Events he bets on and the amount on which the value of the eventual win depends (hereinafter referred to as "Stake"). Bets will be accepted in a non-stop system, on the Bookmaker's website, only from customers who have a game account, registered according to the applicable Terms and Conditions.
- (3) The contract will be concluded between the **Bookmaker** and the **Client** based on the latter's voluntary acceptance of the offers, drawn up in accordance with these Regulations, by paying the betting ticket (hereinafter referred to as the "**Ticket**").
- (4) **The customer** is an adult natural person, who does not know the outcome of the events he bets on, who has full capacity to dispose of the funds used to conclude the Contract, who has a game account registered on the Organizer's platform and who agrees with the provisions of these Regulations. In accordance with gambling legislation, persons under the age of 18 and employees or collaborators of the Bookmaker do not have the right to register on its online platform and/or participate in the gambling games organized by the company. Any bets made/accepted in violation of paragraph 1 of this chapter are considered void and result in the non-payment of any winnings related to such bets.
- (5) The regulation is binding for all parties that establish relations for the purpose of placing a bet. All bets received by the Bookmaker will only stand if they are placed in compliance with these Regulations.
- (6) Any misunderstandings regarding the interpretation of the provisions of this Regulation do not give the Clients who invoke these misunderstandings rights that are not provided for in the Regulations (e.g.: the right to the return of the Stake since the Client claims that, by mistake, he believed that the bet had another object; the right to win because in the Customer's opinion, but contrary to the Regulation, a bet is a winner, etc.). Likewise, the Bookmaker is not responsible for confusions and misunderstandings caused by the Clients' ignorance of the official rules specific to an Event they have bet on.
- (7) The bookmaker offers bets on events in the following sports: football, tennis, hockey, basketball, handball, volleyball, rugby, boxing, other contact sports, athletics, cycling, golf, skiing, baseball, American football, car and motorcycle racing, racing of horses, snooker and bets for other events that occur without the involvement of the organizer.

The bets proposed by the bookmaker are sports bets (on events within sports competitions) and bets on events generated by an independent computer system.

Bets accepted by the Bookmaker are SOLO, COMBINED and SYSTEM (single or fixed).

The bookmaker reserves the right to refuse or limit betting on a particular event or only on certain results of it at a given time, in this case the mention 'BLOCKED' appears in the list.

(8) **The solo** bet represents the bet made by the Customer by selecting and registering on the ticket a single sporting event. The winning condition for this type of bet is to indicate the correct prediction on the result. The amount won is determined by multiplying the **QUOTE** by the **STAKE.**

This bet will only be accepted if the event in question has no betting restrictions (eg: a match in the national football championship of Croatia can only be accepted together, on the same ticket, with 3 (three) other events, whatever they are, even from the same championship).

Betting restrictions will be displayed on the site and will be established by the Bookmaker based exclusively on the degree of risk of the events in certain competitions.

(9) **The combined bet** involves selecting several events and entering them on the same ticket. In this case, the final odds are determined by multiplying the individual odds of each event.

The winning condition of this type of bet is the correct indication of the result for each individual event, the amount won being determined by multiplying the final odds (the product of the odds of the events) with the stake played.

The bookmaker reserves the right to restrict the selection of the number of events in a particular championship or competition on the same ticket. These restrictions will be made known to the players by posting them on the Organizer's website.

(10) **The system bet** involves the selection of several events from the offer (min. 2, max. 50) for which the customer chooses the minimum number of results that must be indicated correctly for the ticket to be declared a winner. The number of variants is determined mathematically according to the formula of combinations of 'n' taken by 'k'. The tables representing the number of variants for each type of combination will be displayed on the Organizer's own website.

<u>The simple system bet</u> requires the correct indication of the results for the minimum number of events chosen, in this case the maximum gain is calculated through a mathematical algorithm taking into account the stake played and a coefficient of the odds of the events for which the exact results were offered. The more exact results are compared to the chosen minimum, the higher the amount won.

<u>The fixed system bet</u> involves selecting, in addition to the events from the combinations (for which the minimum condition is met), a number of events (between 1 and 48) for which it is mandatory to indicate the exact prognosis. This bet is a combination between the combined bet and the simple system bet, the maximum win being a function of the bet played, the product of the odds of the events selected in the system and the odds calculated according to the previous paragraph for the events in the combinations.

- (11) The events proposed for betting by the bookmaker are included in the daily offer (hereinafter referred to as **LIST**), displayed on its website.
- (12) The **LIST** includes the following data: the day and start time of the event, the event code, the competitors (as a general rule, the home team is listed on the left side, even if the event takes place on a neutral ground), the odds established for the possible results of the event, any other data of interest (betting conditions/restrictions / disputing the event on neutral ground, etc.).

ODDS means a numerical value that the Bookmaker assigns to a sports event prediction.

(13) The odds of the events fixed by the bookmaker are not negotiable. They may fluctuate over time, up to the date and time of the start of the event, but the rate accepted by the customer and written on the ticket remains valid regardless of subsequent changes, under the conditions of these Regulations.

The quota can be set separately for each event, as part of a combination or for a total combination, respectively for all the events that make up the combination in question.

If the odds are fixed for each individual event, the combination odds are obtained by multiplying the odds of all individual events.

- (14) The information in the list regarding the start time of the events has only an indicative role.
- (15) The customer selects the events from the list, indicates the results he wants to bet on, sets the amount of money he wants to bet (**Stake**) and the type of bet.

B. The betting ticket

(16) The ticket must include the following data: the name, the unique registration code and the logo of the organizer, the date and time of issue, the code of the event and the type of bet, the competitors (abbreviations are allowed), the forecast chosen by the customer, the odds at that moment of each prediction, the final odds (except for system bets, in which case the mention COMBINATIONS will be printed), the amount paid by the client, the stake, the maximum possible win.

If the maximum win per ticket is not reduced by the customer, the system will send the ticket to the game account with the mention of the maximum allowed win, regardless of the value that would result from multiplying the odds with the stake placed in the game.

- (17) Electronic betting tickets will be archived by the Bookmaker in its archive; for security reasons, they can also be stored in a secondary archive.
- (18) Customers have the obligation to verify the data selected and entered on the ticket, and to send the electronic confirmation of its content, the ticket cannot be cancelled.
- (19) A ticket can contain a maximum of 50 events.

C. Minimum Bets and Maximum Wins. The method of awarding the winnings

(20) The minimum stake placed in the game is 1 lei, and the maximum amount that can be obtained on the basis of a betting ticket is 250,000 lei. The bookmaker may set or change the minimum values of the stakes placed and the maximum values of the winnings obtained by a participant from participating in the game of chance (maximum winning

related to a betting ticket or series of identical tickets) with the prior approval of ONJN. The information regarding the minimum stake values, respectively the maximum winning values, will be posted on the organizer's website at least 24 hours before their entry into force.

- (21) For each accepted bet, the Bookmaker may additionally charge administrative fees between 0 and 5% of the stake general expenses.
- (22) The number of tickets that can be requested by a player is unlimited. The bookmaker reserves the right not to accept or cancel a second identical ticket.
- (23) The winnings will be calculated based on the odds valid at the time of ticket acceptance, with the exceptions provided in these Regulations.
- (24) As a rule, in case of validating the winnings, they are paid after the expiration of a maximum period of 30 minutes from the end of the last event registered on the ticket, by transferring the amounts related to the winnings to the Customer's game account. Exceptionally, the payment can be made in a maximum of 3 calendar days from the date established in the previous paragraph.
- (25) The bookmaker establishes the official result of an event based on the statistical reports officially published by the organizer of the event in question (national or international federations and associations, leagues, cups, etc.).
- If the results of the events forming the object of the bet (eg: number of corners, the team that will have the opening kick of the match or others) are not presented on the official website of the event organizer, they will be taken over by the organizer from specialized sites.
- (26) The winnings are transferred to the game account of the Customer, who has the right to order their withdrawal using the same method as that used for the transfer of own funds to the game account (if the amounts were deposited in cash in the Bookmaker's betting agencies, the customer will be able to request that the payment of the winnings be made in cash, in the agencies).
- (27) The bookmaker has the right to suspend payment of winnings if there are suspicions of fraud or any other irregularities in connection with the game account or the betting tickets or if the events on which the bet is under investigation by Romanian or foreign competent bodies .
- (28) According to the provisions of Law no. 227 of September 8, 2015 regarding the Fiscal Code, with subsequent amendments and additions, winnings from games of chance (implicitly fixed odds online bets) are taxed as follows:

up to and including 10,000	3%
over 10,000-66,750 inclusive	300 + 20% for what exceeds the amount of 10,000
over 66,750	11,650 + 40% for what exceeds the amount of 66,750

The tax due is determined and withheld by the Organizer for each transfer from the game account to the bank account or similar.

(29) The maximum winnings specified in these Regulations are applicable to any Client or groups of clients acting together, using the same or similar combinations of selections, even if they are made on several series of bets, on several days or using different accounts. If the Organizer discovers identical or similar series of tickets held by a customer or a group of customers, the total sum of the winnings from them will be limited to the value of a maximum win.

D. The betting mechanism

- (30) Prediction symbols generally have the following meaning:
 - 1 for the victory of the team listed on the left side of the offer (host of the event);
 - X for equality (in the case of sports where applicable);
 - 2 for the victory of the team listed on the right side of the offer.
- 1X for the victory of the team listed on the left side of the offer (host of the event) or a tie;
- 12 the victory of the team entered on the left side of the offer (host of the event) or the victory of the team entered on the right side of the offer;
 - X2 for a tie or victory of the team listed on the right side of the offer;

Double symbols (1X, 12 and X2) will hereafter be called "double chance".

- (31) In motor sports, athletics, horse betting, skiing, predictions are symbolized by letters, usually having the following meaning:
 - V for the race winner;
 - L for ranking in a certain place, for example on the podium;
 - P for ranking on places with points, for example places 1-8 in the case of formula 1.

(32) **HANDICAP** bet is the bet for a specific event in which the team with fewer theoretical chances is given a handicap (a "score") that the favorite team must overcome in order to be declared the winner. Alternatively, a customer betting

on the team that has been given a handicap can win if the player they are betting on loses the match but covers the handicap. Handicap is a mention (notation, indication) given by the organizer to one of the participants in the sports event in question, being written in his right in the betting offer.

33) (**Football betting**: final result (1, X, 2), double chance (1X, 12, X2), first half (1r), second half (2r), halftime/final (45/90, p/f), goals handicap (h), both teams score (gg), only one team scores (vs), even/odd number of goals (even/odd), kick-off, total corners, penalty in the match, yellow cards, red cards, player scores (not including own goal) (name yes), player scores the first goal of the match (not including own goal) (first scorer + name), team making first change, team scoring first out, minute of first goal, total shots, shots on the goal area, total fouls, possession of the ball, total offsides and others.

Exclusively in the case of betting on football matches, the Bookmaker offers the possibility of **betting on the results of a stage of an event that takes place in stages** (for example, without limitation, national / European / World Championship, qualifications for the European or World Championship, Cup, etc.).

The event that the Bookmaker can include in the betting offer consists in indicating the total number of goals scored in a stage of the sporting event, by reference to the value indicated by the Bookmaker in the betting offer.

If the result indicated by the Customer is that fewer goals will be scored in a stage than those indicated in the betting offer, the symbol below will be written on the betting ticket, and if the result indicated by the Customer is that the number of goals scored will be higher than the number indicated by the Bookmaker, the over symbol will be written. On the same betting ticket, the events in the previously described category (bets on a stage of a football event) can be combined with bets on any other events, with the exception of those in the " *Total goals* " category.

The ticket registered with non-compliance with this provision will be considered null, the events being given a rate of 1.00

If one of the matches scheduled in a stage of the football event does not take place, whatever the reason for its postponement or cancellation, it will be considered that its result consists in the scoring of 2 (two) goals.

If, during a stage of the event, no more than two matches take place, the bet will be considered void, the event being given a rate of 1.

- (34) **The CHANCE football bet** is a special type of bet of two combined bets (eg final result and first half), where one of the two bets must be correctly indicated.
- (35) **The COMBINAZZII football bet** is a special type of bet of two combined bets (e.g. final result and total goals), where both bets must be correctly indicated cumulatively.
- (36) **The DOUBLE WIN soccer bet** is a special type of bet where the indicated team must win both the first half and the second half.
- (37) The football bet DOUBLE HANDICAP WIN is a type of bet where the indicated team must win by two goals.
- (38) **The football bet SURE VICTORY** is a type of bet where the indicated team must win to nil (without the opposing team scoring).
- (39) **Tennis betting**: match winner (1, 2), handicap match winner (h), first set (1s), total games in the match, exact number of sets (ts) and others.
- (40) **Ice hockey betting**: final result (1,2), double chance (1X, X2, 12), first period (1p), second period (2p), third period (3p), total goals and others.
- (41) **Basketball betting**: final score (1,X,2), final score with handicap (h), double chance (1X, X2, 12), first half (score after the first two quarters) (1r), total points and other.
- (42) **Handball bets**: final result (1,X,2), final result with handicap (h), double chance (1X, X2, 12), first half (1r), total goals (tg), total first goals half (1st), total goals second half (2nd), and others.
- (43) Rugby and American football bets: final result (1, X, 2), final result with handicap (h), first half (1r), total points and others.
- (44) **Volleyball betting:** final result (1, 2), final result with handicap (h), first set (1s), second set (2s), total points in the match, exact number of sets (ts) and others .
- (45) Water polo bets: final result (1, X, 2), final result with handicap (h), first half (1r) and others.
- (46) Baseball bets: final result (1, 2), total points and others.
- (47) **Betting on motor sports, skiing, horse riding, athletics**: pole position, winner, ranking in the top three, ranking in points, duel between athletes and others.
- (48) The **ANTEPOST bet** is the bet aimed at the winner or the place occupied by an athlete/team in a sports tournament of any kind (eg: Roland Garros winner, Premier League winner, R. Federer in the Wimbledon final, etc.).

Antepost bets are accepted until the start of the first match of the respective tournament, they can be entered on the ticket in the system and/or combinations with other events in the list, but the payment of winnings is made only after the end of the tournament, even if the forecast is correct from its development (e.g.: mathematically, with three legs to go, Arsenal are champions).

(49) The **WINNER bet** is a special bet where one of the competitors wins (applies to team sports only). If the event ends in a draw, the bet receives odds of 1.00.

- (50) The HALF- TIME PRONOSTIC bet is a special bet in which, for some events, during the break of the match, the bookmaker sets new odds for the part of the match to be played, having no elements in common with the "second half" bet, being a reduced version of the bet "live".
- (51) On a daily basis, the bookmaker can offer customers special types of bets. These events are selected from the list, receive a new symbol and are given special odds (**CRAZY ODDS**).

Bets on these matches can be played solo or in the system and/or combinations with any other event in the list, except for the event from which it derives.

(52) LIVE BETTING (lb) are a type of fixed odds betting in which the Client indicates the results of the events proposed by the Bookmaker during their development. The events are selected from the list and are announced to the public as events that can be *bet on live* .

Live bets are bets with special rules, which are an exception to the general rules.

The valid rate is the one printed on the betting ticket played, with the exceptions provided by these Regulations.

(53) For *LIVE Betting*, in case of interruption of a sporting event, at any time during the match, all bets on the ongoing event whose epilogue has been made, are considered valid. If the sports event is interrupted, and its continuation occurs within 12 hours from the time of the initial start of the event, all bets registered during the event and/or before the interruption and whose end is not yet known, are considered valid and for the continued event. If a sporting event is interrupted, and its continuation does not occur within 12 hours from the initial start time of the event, all LIVE bets played during the event and which have not already been completed, are not considered valid, they receive the quota 1 00

Bets recorded on tennis matches, which after registration are interrupted and not resumed within 24 hours from the moment of interruption, will be considered void, being approved at odds 1, if they were not completed before the interruption.

(54) The bookmaker reserves the right to propose other types of bets related to the sports disciplines specified above, by including them in the list and displaying them on its own platform.

(55) **BETTING ON NUMBERS** are:

- i) bets made on events consisting of number draws made at lotteries or
- ii) bets made on events on events consisting of number draws made in **Keno games** by companies authorized in this sense from the following countries, without the enumeration being limiting: Austria, Belgium, Finland, France, Hong Kong, Ireland, Italy, Latvia, Hungary, Germany, Pennsylvania, Poland, Slovakia, Spain, Switzerland.

Bets on numbers are not possible on events consisting of number draws carried out by the National Lottery of Romania. Depending on the bookmaker's decision, the offer of events for betting on numbers can be extended or restricted.

The number draws performed in the Keno games use drawing systems similar to those encountered in the draws performed by lotteries. The organizers of the Keno games determine the total number of numbers from which the draw will be made. From the total numbers, 20 (twenty) numbers will be drawn.

Bets on numbers drawn in lotteries or keno games do not imply the direct participation of the players in the lotteries or keno games offered by the bookmaker.

Betting on numbers is possible only on natural numbers or on a string of natural numbers. Complex numbers cannot be the subject of betting.

For each draw, the Bookmaker sets the values for each individual combination.

A maximum of 15 numbers can be played on a single ticket.

The maximum possible win on a single ticket or on a series of identical tickets is 250,000 lei even if the amount obtained by multiplying the odds with the stake would be higher.

i) Bets on the numbers drawn in international lotteries

The times of the draws are those announced by the lottery organizers. The time period between draws is regulated by the laws of the state of the organizer and can vary from a few minutes to a few days.

Each draw included in the Bookmaker's offer is assigned a round sequence number, date and time of the draw.

Bets on numbers are accepted until the time shown in the Bookmaker's offer.

If, by mistake, a bet was accepted on a previously held or ongoing draw, it is considered void, the event being given a rate of 1.

If two draws of the same lottery take place in one day, it will be considered that the event bet on is the main draw or the one held first, if it cannot be determined which of the draws has a main character.

If a draw (or more) was not carried out at the initially scheduled time for any reason, the bets on the numbers made will be considered valid for the next draw (or draws) of the same lottery, except for the situation where, at the Customer's request, the Bookmaker canceled the bets before the draw.

The minimum bet for an individual ticket is 1 Leu.

The results of the lotteries or keno games will be validated by the bookmaker, based on the data entered in the official websites of the organizers of the draws. If there are inconsistencies between the information provided by the Bookmaker on its own site or in other informative documents (list of results or similar documents, displayed) and the

information published on the organizers' websites or held by the Organizer in the central IT system, the results draws are validated based on the latter.

Only the combination of numbers that does not include any wrong indicated number is considered a winner.

The number betting events cannot be combined on the same betting ticket with other events from the Bookmaker's betting offer.

The events of betting on numbers arising from the development of a lottery can be registered on the same ticket, it being forbidden to combine two or more events within two or more lotteries on the same ticket. Tickets registered in violation of this prohibition will be considered void, and will be given a 1.00 rate.

Bets on numbers will be considered winning only if they fully contain the combination of winning numbers.

For example, if a winning combination has eight numbers, the winning ticket cannot contain fewer numbers (seven, six, five, four, etc.).

For all situations that are not specifically provided for in this article and refer to betting on numbers, the corresponding general rules set forth in these Regulations apply.

ii) Bets on drawn numbers in the Keno Greece game

The following events will be included in the Bookmaker's betting offer, valid only for number draws in *keno games* organized by OPAP Group Greece:

- The sum of the numbers drawn the participants will indicate whether the total value of the 20 numbers drawn is higher or lower than the value set by the Bookmaker;
- The sum of the 3 smallest drawn numbers the participants will indicate whether the sum of the 3 smallest drawn numbers is lower or higher than the value set by the Bookmaker;
- **Sum of the 3 largest numbers drawn** participants will indicate whether the sum of the 3 largest numbers drawn is lower or higher than the value set by the Bookmaker;
- The sum of the 5 smallest drawn numbers the participants will indicate whether the sum of the 5 smallest drawn numbers is lower or higher than the value set by the Bookmaker;
- **Sum of the 5 largest numbers drawn** participants will indicate whether the sum of the 5 largest numbers drawn is lower or higher than the value set by the Bookmaker;
- The smallest number drawn the participants will indicate if the smallest number drawn has a lower or higher value than the reference value, preset by the Bookmaker;
- **The highest number drawn** the participants will indicate whether the highest number drawn has a lower or higher value than the reference value, preset by the Bookmaker;
- **Even/Odd of the total numbers drawn** participants will indicate if, during a game round, more even numbers than odd numbers will be drawn or if even and odd numbers will be equally drawn.
- **Total even numbers drawn** participants will indicate if the total number of even numbers drawn will have a lower or higher value than the reference value, preset by the Bookmaker; (the event does not require the correct indication of the total value of the even numbers drawn, but only the number of symbols even numbers drawn.)
- The smallest number drawn even/odd the participants will indicate whether the smallest number drawn will be even or odd, respectively;
- The highest number drawn even/odd participants will indicate whether the highest number drawn will be even or odd, respectively.

Greece Tombo

Greece Tombo is an additional game in the drawn number betting category within Keno Greece. For this game, the following betting possibilities are available:

- **G2** – participants will select **two numbers** from 1 to 80; to be declared a winner, the two numbers must be drawn in that round. The rate at which the bet will be approved is the one established for the order number of the second ball drawn (respectively of which ball the second ball selected by the participant was drawn).

The win is the stake multiplied by the odds shown in the table shown within the round.

- **G3** - participants will select **three numbers** from 1 to 80; to be declared a winner, the three numbers must be drawn in that round. The rate at which the bet will be approved is the one established for the order number related to the third ball drawn (respectively of which ball the second ball selected by the participant was drawn).

The win is the stake multiplied by the odds shown in the table shown within the round.

- **G4** - participants will select **four numbers** from 1 to 80; to be declared a winner, the four numbers must be drawn in that round. The rate at which the bet will be approved is the one established for the order number related to the fourth ball drawn (respectively of which ball the fourth ball selected by the participant was drawn).

The win is the stake multiplied by the odds shown in the table shown within the round.

- **G5** - participants will select **five numbers** from 1 to 80; to be declared a winner, the five numbers must be drawn in that round. The rate at which the bet will be approved is the one established for the order number related to the fifth ball drawn (respectively of which ball the fifth ball selected by the participant was drawn).

The win is the stake multiplied by the odds shown in the table shown within the round.

- iii) Against Greece Keno (20/80)
- 1. Bet on the numbers that will not be drawn during the selected/indicated round, from the Grecia Kino 20/80 lottery.
- 2. You can select/indicate a maximum of 10 numbers that will not be drawn in the respective round in the case of standard (fixed) betting. In the case of the System betting type, a maximum of 15 numbers (combination) can be selected.
- 3. The win is calculated as the product of the odds and the stake.
- 4. The betting ticket is a winner if the numbers the player bet on are not drawn in the chosen round.
- 5. It is possible to bet the system. The minimum bet per combination, in the case of system bets, is 0.1 RON.
- 6. The minimum stake per ticket is 1 RON.
- 7. The maximum win per betting ticket is 250,000 RON.
- 8. For system type bets, only those indicated within the system, which are not drawn during the respective (selected) round, are winners.
- 9. There are fixed odds for each selection a player bets on. The odds are shown in the table below.

- 3. The profit is calculated as the product of the quota and the stake.

56) VIRTUAL BETTING

Virtual bets are bets on events randomly generated by an independent computer program.

The virtual betting games included in the Mozzartbet offer, as well as their description, betting rules, betting method and options, theoretical payout percentage and any other specific conditions are provided in the <u>Annex to</u> this regulation, which is an integral part of it.

57. Betting on electronic sports (E-Sports)

57.1. General rules

The approval of bets will be based on the official results, announced by the competent forums within the punctual competitions, TV transmissions or the API (programming interface) of the game.

The kick-off times and innings displayed on our website are for information only and we do not guarantee that they are correct

In the event that a team officially changes its name or a team name change occurs as a result of leaving one organization to join another, all bets will stand.

57.2 Situations in which rate 1.00 is applied:

In the event that team 1 or 2 does not appear on time on the server, then other teams are automatically considered winners;

If team 1 or 2 does not appear in the tournament when it is played (tournament);

If team 1 or 2 are disqualified because they cheated;

When the match is drawn on the "best of 2" system

If a match is not played within 50 hours from the initially scheduled time;

If the wrong team was entered in the match within the same Organization (Ex: Academia Fanatic and Fanatic are not the same team);

57.3. Counter Strike (CS:GO)

Bets on the map (Map) – Bets are canceled if the statutory number of maps (maps)/rounds (rounds) is changed or differs from those offered for betting purposes.

Bets per round (round) – If a round is restarted due to a disconnection or an impossibility to play related to a technical problem, the pre-game bets will remain on the restarted round according to the official result. All "in-play" bets on the affected round will be void unless the result is already determined and the restarted round will be treated as a separate entity.

Kill Markets Bets: Will be settled based on the official table, telecast or game API (game programming interface).

Bomb Markets bets: Will be settled based on the official table, telecast or game API (game programming interface). Tournament Winner bet – is a direct bet for the winner of the entire tournament. If there are eight teams competing, odds will be offered for each of them. The favorite team has the lowest quote, and the team with the fewest chances has the highest quote.

57.4. League of Legends (LOL)

Map Bets: - in the event of a tie, Map Win Bets are considered void.

First Blood Bets - Only results for players killed by the opposing team will count.

Kill Bets - Will be determined based on the official table, telecast or game API (game programming interface)

Creep/Monster Bets - These bets will be settled based on the official table, telecast or game API (game programming interface).

Building Bets - For building destroyed bets, all buildings are considered to have been destroyed by the opposing team, regardless of whether the last hit was by a Champion/Hero or Minion/Creep, and even if the building comes back to life or not.

The number of barracks will be determined by the individual "ranged" and "melee" type barracks destroyed . In the event that someone surrenders, the final number of Towers and Inhibitors/Barracks available will be determined based on the minimum number of Towers and Inhibitors/Barracks required to win the game at the time of surrender. These additional buildings will be treated as destroyed by the winning team and are limited to five Towers and one Inhibitor/Barracks.

In case of a surrender, bets on the "Next Buildings Destroyed market" will be cancelled.

Duration Bets - All event duration bets will take into account the actual game time and will not include the period before minions or creepers spawn. In the event of an event that has started but is not finished, bets will be void unless the outcome has already been determined.

57.5 Dota 2

Bets on the map (Map) - in the event of a tie, the bet will be void;

First Blood markets bet : - only kills by the opposing team are taken into account;

Kill markets betting (kills): - Will be settled based on official table, telecast or game API (game programming interface). Creep markets bet: will be settled based on official table, telecast or game API (game programming interface).

The placement will be determined by the team, to take down Roshan, and not by those who collect "Aegis of the Immortal"

Building markets bet: for settlement purposes, all destroyed buildings are considered to be destroyed by the opposing team, regardless of whether the last hit was by a Hero or a Creep. The number of "barracks" will be determined based on the number of "barracks" destroyed individually ("range" or "melee").

In the event of a surrender, the final number of Towers and Inhibitors destroyed will be set to the minimum number of Towers and Inhibitors required to win the game at the point of surrender.

These additional buildings will be treated as if destroyed by the winning team and will be limited to five Towers and one Inhibitor.

E. Bonuses

(58) The bookmaker may decide to grant additional winnings (*Bonuses*) for certain events, for certain types of bets or for tickets registered in a predetermined period.

The conditions for participation and awarding bonuses, the categories of events to which they apply, the validity period of bonus awarding campaigns, as well as any other necessary information will be displayed on the Organizer's own website with at least 48 hours before their entry into force.

F. Rules regarding approval and validation of winnings

(59) For all sports disciplines, the final result is considered the one recorded at the expiration of the regular playing time, including the extra minutes granted by the officials for normal interruptions during the game.

By way of derogation from this provision, for the validation of the results of the bets that contain events that presuppose the indication of the team/player that qualifies in the next round, the results recorded at the end of the sports competition, including the overtime periods and possible penalty kicks, will be taken into account.

Bets registered on an event whose unfolding does not comply with the usual rules regarding the duration or division into halves (for example, the football match takes place during three halves instead of two, regardless of whether the playing time is respected; the hockey match is play over four halves instead of three as usually structured, even if the total playing time of 60 minutes is respected; etc) will be rated 1.

This rule is also applicable to friendly matches.

The Bookmaker may decide to insert into the Betting Offer events that are known to have an atypical development, making an express mention of this situation and including in the Offer events specific to the modalities in which the sports competition is to be held.

Only in this case, bets on atypical events will be able to be validated according to the quota given to the event in the Betting Offer.

No change or subsequent decision, individual or of any committee (including subsequent decisions of the referee or the green table) will be taken into account.

- (60) In the event that a sporting event that can be divided into two halves (football, basketball, handball, water polo, rugby sa) is interrupted during its performance (unfavorable weather conditions / incidents in the stands, etc.) and it is not replayed within 50 hours of the scheduled start of the event, we encounter two situations:
- if the event was interrupted during the first half, bets receive odds of 1.00;
- if the event was interrupted during the break of the match, the bets whose result was not achieved before the interruption (for example, the bet on the author of the first goal in the 2nd half) will be cancelled, applying the rate 1.
- if the event was interrupted for the duration of the second half, the result recorded at the time of the interruption is considered the final result, and the bets will be approved according to the *table speaks principle*.

Regarding the basketball and water polo matches (which take place in 4 halves - "quarters"), the break of the match will be considered the one between the second half and the third half (the longest break, intended for the players to rest). In this sense, in the case of these sports, the "first half" will mean the first 2 quarters, and the second half, the last 2 quarters.

Odds of 1.00 are given if the replay of the game takes place under different conditions than the initial ones (for example: change of venue).

(61) For basketball matches, the Bookmaker allows betting on events of the "Player scores points" type, which consist in the exact indication of the number of points scored by a certain player in a certain match or the indication of the number of points scored in relation to a reference value (limit) set by the Bookmaker.

The following betting rules apply to this type of game:

a) The "single" bet is accepted (one event per ticket).

- b) You can bet on the total number of points registered, under (<) and over (>) the limit set by the Organizer.
- c) This type of bet is accepted on the ticket and together with other types of bets if their object is represented by events from the same sports competition (match).
- d) If the match is not played at the initially set date and time, the bet will receive the 1 rate.
- e) In the event of interruption of the event, the bet will be given rate 1.
- f) In the case of the "Player scores points" bet, the 1st rate will be given to the event consisting of indicating the number of points (baskets) scored by a certain player if he does not participate in the event (he is on the bench, but does not enter the court at all game).
- g) For bets on events within the "Player scores points" game, the results are approved taking into account any overtime periods.
- (62) For tennis matches, by exception to art. 58, if the players finished the match before completing the normal stages of the game due to the abandonment of one of them (injury, resignation, disqualification, etc.), the bet is considered void and the odds 1.00 are calculated.

If a player withdraws after the start of the match, odds of 1.00 are given for all types of bets on this game (Final result without handicap, Final result, First set, Handicap games, Number of sets, Number of games, Number of games -s the first set), regardless of when the match was interrupted and regardless of whether the first set was completed or not.

- (63) In the event that an event is postponed by an official decision and is not replayed within 50 hours from the scheduled start of the respective event, all bets will receive the odds of 1.00.
- (64) In the event that an event is abandoned before it starts or even during the course of the event because one of the teams does not show up at the start or leaves the field, all bets not completed until the moment of abandonment will receive the odds of 1.00.

The same situation for events officially interrupted in the course of their development due to the elimination of several players when, according to the regulations, a team can no longer continue the game.

- (65) In the case of motor sports, skiing, athletics and equestrian competitions, the winner of the race, respectively the winner of the duel (in the case of duel-type bets) is the one who finished the entire race first. Subsequent decisions are not relevant to the outcome of the bet. If a competitor does not qualify for the race, all types of bets on that competitor are considered void. If a competitor abandons the race before the actual race, all predictions are not taken into account and the odds 1.00 are calculated. If a competitor fails to start the race, he is considered to have lost the duel, except for the situation where the one he is dueling with did not even qualify for the race. If one or both competitors give up the race, the one who stayed longer in the race is considered the winner.
- (66) In the case of volleyball matches, if three sets have been completed, the result on the scoreboard is taken into account, otherwise the odds are 1.00.
- (67) In the case of hockey matches, if the match is interrupted in the first two thirds, the match is not taken into account for any type of bet and the odds 1.00 are calculated. If the match is interrupted at the end of the second period, but before the start of the last period, as at any time during the last period, the result from the moment of the interruption is taken into account for any type of bet.
- (68) In the case of baseball matches, if the match is interrupted for any reason and does not continue until the end of the betting day, odds of 1.00 are calculated for any type of game.
- (69) For all other sports and games, in the absence of special rules defined in the list of events, displayed on the Organizer's website, the general rules will apply.
- (70) All bets for which, regardless of the reason, the actual start time of the event precedes the time of issuing the ticket, will receive the odds of 1.00.

The organizer has the right, in the event of an error regarding the time or place of the start of the event or a typographical error or any type of error regarding the odds published in the betting offer, to declare the event in question void, giving the events a rate of 1.00

(71) In the event that a sports event from the betting offer takes place on neutral ground, the Organizer does not have the obligation to mention the exact place of the event in question.

G. CASH OUT

- 1. The Cash Out option allows you to close an ongoing bet early, before the outcome is decided.
- 2. The winnings that the bettor will receive after using the Cash Out function depends on the winning odds of the ticket at that time.
- 3. This option is valid for single and multiple, pre-match or Live bets on a variety of sports and betting options.
- 4. In the case of changes in rates or if where an event is suspended, the Cash Out option could not be available.
- 5. Mozzartbet cannot guarantee that the Cash Out option is available for the bet you select.
- 6. If the Cash Out option is not available for technical reasons, bets will be settled as originally placed, Mozzartbet being exempt from liability.
- 7. Mozzartbet reserves the right to change, suspend or remove the Cash Out option at any time and in respect of any event. In these cases, bets will be settled as originally placed.

H. Final Provisions

- (72) Persons who have not reached the age of 18, as well as employees and collaborators of the Bookmaker, are not allowed to participate in the betting activity organized by it.
- (73) The representatives of the bookmaker (executive or management staff, collaborators, etc.) will not make public the data on the players or the company except in cases expressly stipulated by the law, or with the consent of the player.
- (74) The bookmaker reserves the right not to pay the winnings claimed by the player, if evidence of bet fraud is found or if competent bodies find and make public the fraud / rigging of the result of an event.
- (75) Players who do not comply with the provisions of these Regulations, the Organizer may prohibit them from participating in remote fixed-odds bets organized by it, under the conditions stipulated in the Terms and Conditions applicable to the remote gambling activity carried out by MOZZARTBET MALTA LIMITED
- (76) MOZZARTBET MALTA LIMITED is a personal data operator. The company processes personal data provided by the players, namely the name and surname, signature, personal numerical code, series and number of the identity document, for the purpose of submitting declarations to the tax authority, as well as the organization of gambling. Any person has the right to object, on legitimate grounds, to the processing of data concerning him. This right of opposition can be excluded for certain processing provided by law (eg: processing carried out by the financial and fiscal, political, justice, social security services). Anyone has the right to object, free of charge and without any justification, to the processing of their personal data for direct marketing purposes.
- (76) These Regulations are brought to the attention of the participants by posting them on the Organizer's website. Any modification thereof will be subject to the prior approval of the competent authority, the National Office for Games of Chance, and will be objectionable to the participants only after being posted on the website.
