# PROMOTIONAL CAMPAIGN REGULATIONS Free Bet Mania

### **SECTION 1. Introductory Provisions**

1.1. The **Free Bet Mania** promotional campaign (hereinafter referred to as the "*Campaign*") is organized by **Mozzartbet Malta Limited**, a Maltese company with registered office in Soho Office, Punchbowl Centre, Office 2D, St. Elia Zammit, St. Julians STJ3154, Malta, registered in Malta Companies Register under number C83980/2017, hereinafter referred to as Mozzartbet or the Organiser.

1.2. The promotional campaign is carried out in order to promote the activities carried out on the <u>www.mozzartbet.ro platform</u> and the services offered by Mozzartbet. Participation in the Promotional Campaign does not involve the payment by the participants of a participation fee, i.e. any additional expenses, nor the price increase that the product had previously.

1.3. The Campaign will take place according to the provisions of these Campaign Regulations (hereinafter referred to as "*Regulations*"), knowledge of which and the General Terms and Conditions of the Organizer are mandatory for all participants. These Regulations are made available to the public free of charge, by displaying them on the Mozzartbet Malta website, <u>www.mozzartbet.ro</u>, during the entire period of the Campaign. By simply participating in the Campaign, it is assumed that the Participants are aware of and unconditionally accept the terms and conditions of these Regulations.

1.4. Mozzartbet, as the Organizer, reserves the right to modify or change the Regulation, and the changes will enter into force on the date of their publication on the official website of the Organizer.

### **SECTION 2.** Venue of the Promotional Campaign

The promotional campaign will take place on the Organizer's online platform, <u>www.mozzartbet.ro</u>.

#### **SECTION 3. Duration of the Promotional Campaign**

The promotional campaign is available starting from 18.06.2024, until 31.12.2024, in several stages, the day(s) being announced in advance by the Organizer on the website.

#### **SECTION 4. Right to Participate**

4.1. Any natural person who meets the following conditions (assessed cumulatively) can participate in this Promotional Campaign:

- a) Is at least 18 years old;
- b) Has domicile or residence in Romania;
- c) Has a game account on the <u>www.mozzartbet.ro platform</u>;

d) The organizer can determine the fulfillment of one or more of the following categories of conditions for certain stages of the Campaign:

- making a deposit to the game account, having the minimum value indicated by the Organizer; and/or
- successful completion of the game account verification procedure within a certain maximum term indicated by the Organizer; and/or
- registration under certain conditions of a betting ticket within a certain maximum term indicated by the Organizer; and/or
- other objective conditions having as their object, for example, the activity on the Organizer's platform.

Depending on the relevant stage of the Campaign, all details regarding the conditions under this letter d), respectively, for example, the minimum amount of the deposit, the term in which the verification procedure must

be completed, will be announced in advance by the Organizer, on website <u>www.mozzartbet.ro</u>, in the special section dedicated to the Campaign.

4.2 I cannot participate in this Campaign, even if I fulfill the provisions of art. 4.1. above, the employees and collaborators of the Organizer or other persons in an interdependent relationship with it.

# **SECTION 5. Campaign Mechanism and Campaign Prizes**

5.1. Participants who meet the conditions provided for in art. 4 will receive the prize which consists of **Free Bet bonus.** For each relevant stage of the Campaign, the value of the Free Bet, the conditions and the term in which it can be used, respectively the term in which it will be transferred to the user's game account, as well as any other relevant conditions regarding the bonus, as necessary, will be announced in advance by the Organizer, on the website, in the section specially dedicated to the Campaign.

5.2. The prize will be transferred to the participant only after fulfilling all the conditions provided for in art. 4

5.3. The winners of the prizes offered in this Campaign do not have the possibility to receive the value in money or other goods of the prizes, nor can they change their characteristics.

5.4. The General Terms and Conditions of the Organizer and the Terms and Conditions for the award of Bonuses apply.

### **SECTION 6. Fees and Taxes**

The parties acknowledge that, in accordance with the provisions of the Fiscal Code, the income obtained by the winners of the promotional prizes, which have a value of more than 600 IE, is taxable. If applicable, these fiscal obligations will be calculated and withheld by the Organizer, who will transfer the related tax to the state budget, according to the legal provisions in force.

#### **SECTION 7. Termination / Suspension of Campaign**

7.1. The campaign may be interrupted / terminated before the deadline in case of force majeure or by a decision of the Organizer determined by the impossibility of continuing it for reasons beyond its control.

7.2. In the event of the occurrence of any of these cases, Mozzartbet will publicly announce the termination or interruption of the Campaign, as soon as possible after the occurrence of the new circumstances.

7.3. Decisions of the courts as well as acts of the competent public authorities, with an impact on the Campaign, are assimilated to the situations considered in point 7.2.

7.3. In the situations considered in points 7.1 - 7.3, the Organizer no longer has any obligation to the participants regarding the return of a monetary amount as compensation or other such.

#### **SECTION 8. Disputes**

8.1. Any disputes arising between the Organizer and the Participants regarding any aspect related to the running of the Campaign will be settled amicably, and if this is not possible, the disputes will be settled in the competent Romanian courts in the city of Bucharest.

8.2. Any disputes arising between the Organizer and the Participants will be resolved amicably or, if this is not possible, the disputes will be settled by the competent Romanian courts at the Organizer's headquarters. Any complaints related to the running of the Campaign can be sent to the following address: Bucharest, Sectorul 2, Str. Mantuleasa no. 15, Building B, Floor 1. After the date of termination of the Campaign, the Organizer will no longer consider any appeals.

8.3. The applicable law is Romanian law.

# **SECTION 9.** Processing of personal data

9.1. The personal data of the participants will be processed by the Organizer in compliance with Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation), as well as any other national regulations in the field of personal data processing.

9.2. All participants are strongly recommended to consult the Organizer's Privacy Policy, available free of charge on the website <u>www.mozzartbet.ro</u>.

### **SECTION 10. Final Clauses**

10.1. The Organizer's decisions regarding the Promotional Campaign are final and applicable to all Participants.

10.2. The Organizer is entitled to take all necessary measures in case of attempted fraud, abuse or any other actions that could affect the image or reputation of the Organizer or its collaborators/partners or the running of the Campaign.

10.3. Participants whose accounts were closed or suspended during the Promotional Campaign, as a result of violating legal and/or regulatory provisions, as well as as a result of self-exclusion, lose the right to participate in the Campaign, as well as any right to the prizes.
